

Plat of Survey for Kenneth and Patricia Riordan

That part of GOVERNMENT LOT ONE (1) in Section Nineteen (19), Township Eleven (11) North of Range Nineteen (19) East, Town of West Bend, Washington County, Wisconsin, described as follows, viz:

Commencing at a point North 66 degrees 35 minutes West, 33 feet from the Southwest corner of Lot 10 of Algoma Plat, a subdivision in said section and running thence North 25 degrees 30 minutes East 50 feet to the point of commencement of the parcel herein conveyed; thence North 25 degrees 30 minutes East 216 feet; thence Northwesterly at right angles 167 feet; thence South 24 degrees West 200 feet; thence South 5.25 degrees West 27 feet; thence in an Easterly direction to the place of beginning.
EXCEPTING THE FOLLOWING: Commencing at a point North 66 degrees 35 minutes West 33 feet from the Southwest corner of Lot 10 of Algoma Plat, a subdivision in said section and running thence North 25 degrees 30 minutes East 80 feet to the point of commencement of the parcel herein conveyed; thence North 25 degrees 30 minutes East 25 feet; thence Northwesterly at right angles 25 feet; thence South 24 degrees West 25 feet; thence in an Easterly direction to the place of beginning.



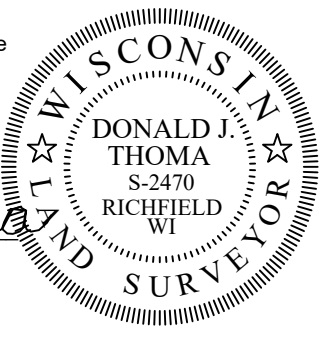

 Bearings are referenced to the Wisconsin County Coordinate System, Washington County Zone (NAD83/2011 WISCORS Adjustment). The south line of the SE 1/4 of Sec. 19-11-19 has a grid bearing of S 89°36'50" E.
 Current zoning = R-1S
 Minimum building setback front = 25' ROW
 Minimum building setback side yard = 7' (existing lot)
 Minimum building setback shore yard = 75'
 Minimum building rear setback = 25'
 This lot is within the Washington County Shoreland Boundary

Note: The description for the west side of West Lake Drive does not recognize the recorded angle point at the most northerly corner of Lot 10, Algoma Plat. This survey is consistent with other previous surveys which shows the width of the right-of-way being consistent at 33.00 feet.
 All elevations are based on NAVD88 datum.
 Benchmark: Master Benchmark is a conc./mon. with a brass cap found marking the north Meander corner for the Southeast corner of Section 19-11-19, which has a recorded elevation of 1034.11 NAVD29 and 1033.91 NAVD88 datums.

 Total existing impervious area (buildings, drives, retaining walls, paver patio and all walks) 3,366 +/- sq. ft. = 9% of lot area.
