**Overview**: Some of the regulations in the City's zoning code only apply along bodies of water that are determined to be navigable. They are depicted on the zoning map. Waterbodies that are mapped as navigable can be examined to verify whether such determination is correct and waterbodies that are not mapped as navigable can be examined to determine if in fact they are.

Governing regulations: The procedures and standards governing the review of this application are found in Article 7 of the City's zoning code.
