General Description Woodys' is a restaurant and tavern with an outdoor seating area on the south side of the building. It is believed the property has been used as such for the past 60 years. At no point, did any of the owners submit an application for a site plan/plan of operation even though various improvements have been added to the property over the years. The purpose of this approval is to formalize existing and proposed operating characteristics and set forth terms and conditions.

Terms and Conditions of Approval

- 1. The operator must submit plans for the dumpster enclosure to the town planner and obtain approval of the same. The dumpster enclosure must be completed within 12 months of this date of approval.
- 2. Volleyball, horseshoes, and cornball are limited to those general areas depicted on the attached site map.
- 3. A tiki bar may be added provided the Town issue a conditional use permit for such use. The attached site map shows where it could potentially be located.
- 4. The existing outdoor lighting for the parking lot may continue. Any change in such lighting will require Town approval.
- 5. The existing outdoor seating for the bar/restaurant may continue. Installation of a gas-fired fire pit within the extent of the existing area is allowed.
- 6. Any music played out of doors shall not be amplified to cause a nuisance as determined by the Plan Commission.
- 7. All signage shall comply with the Town's sign regulations (Ordinance 2018-02).
- 8. Wood fire pits are specifically prohibited.
- 9. The following operating hours apply as specified.
 - **Bar and restaurant**: Monday through Saturday 10:30 am to 2:00 am and Sunday 7:00 am to 12:00 am (midnight)
 - Outdoor seating for bar/restaurant: Monday through Saturday 10:30 am to 10:00 pm and Sunday 7:00 am to 10:00 pm
 - **Tiki bar**: Monday through Sunday 10:30 am to dusk

- Outdoor volleyball: formal league play is limited to one day a week, at the choosing of the operator, from 5:00 pm to dusk
- **Cornball**: daily, 5:00 pm to dusk; formal league play is limited to one day a week at the choosing of the operator
- **Horseshoes**: daily, 5:00 pm to dusk; formal league play is limited to one day a week at the choosing of the operator
- 10. The operator may continue using the existing gravel parking area. The most heavily used parts of the parking lot may need to be paved if fugitive dust becomes a nuisance as determined by the Plan Commission.
- 11. The operator may host special events provided the Town otherwise allows such events in the Town's municipal code.
