1. Call to Order, Pledge of Allegiance

Motion by Commissioner Lewis to recommend to the Town Board the approval of the decision letter amended as follows: Rephrase the sentence of the previous site plan first paragraph changing in the terms and conditions in Number 1 from 12 months to 10 months. Number 4, adding that other outdoor lights will be LED, shielded and pointing down. Number 6, music be limited to before 9pm Monday through Thursday and 10pm Friday and Saturday. The hours of for corn hole, volleyball, and horseshoes will be 9am to dusk for all three. The motion was seconded by Commissioner Reddemann. All in favor. Motion carries.
