Sorry for any confusion, but I don't think they were aware the county hadn't received the CSM. This should actually speed things up because you will obtain comments from the county in their preliminary review and then the town would provide its set of needed edits. You surveyor can then make all the edits at one time vs. multiple revisions.
