The Phantom Ranch Bible Camp has submitted a request to hold their 70<sup>th</sup> anniversary celebration on August 23, 2025. In accordance with their Condition Use Permit, they are required to obtain Town Board approval for all special events that exceed 400 persons. Per the application, no alcohol will be provided or sold.

**Public notice** Aside from being shown on a published meeting agenda, no other public notice is required.

**Review procedure** Pursuant to their Conditional Use Permit, any special event, where more than 400 people are anticipated, the event must be specifically authorized by the Town Board upon recommendation of the Plan Commission. This requirement is intended to allow consideration of traffic concerns, effects on neighboring property, and other factors related to the public health, safety, and welfare.

This letter is supplied with a Special Event Application for our 70<sup>th</sup> Anniversary Celebration for Phantom Ranch. This will be our 70th summer camp season!

Our Conditional Use Permit requires us to get a special event authorization if we anticipate more than 400 people to provide a special event. The special event application is included with this letter.

- 3. The event will feature a 70<sup>th</sup> anniversary celebration program and music concert on our ball field. The music program will begin at 4pm and end at 8:30 pm
- 4. There is plenty of parking available on the camp property.
- 5. We hope to host up to 450 people.
- 6. We would like to end the concert with a short, 10-minute fireworks display. The fireworks display would be from approx. 8:30 to 8:40.
